

TSCA-PBT section 6(h) COMPLIANCE DECLARATION


Environmental Protection Agency (EPA) completed risk evaluations and established new regulatory management program for five PBT chemical substances and published five final rules in the federal register (86 FR 866-932) to regulate five Persistent, Bioaccumulative and Toxic (PBT) chemicals under Section 6(h) of the Toxic Substances Control Act (TSCA).

Following this amendment Marcegaglia Carbon Steel S.p.A. has systematically reviewed its product compliance regarding the following substances:

SUBSTANCE	FINAL RULE
Pentachlorothiophenol (PCTP) CAS 133-49-3	All manufacture, import, processing, and distribution in commerce of the substance and product or articles containing it, for any use, unless the concentrations are at or below 1% by weight.
Hexachlorobutadiene (HCBD) CAS 87-68-3	All manufacture, import, processing, and distribution in commerce of the substance and product or articles containing it.
Decabromodiphenyl ether (DecaBDE) CAS 1163-19-5	All manufacture, import, processing, and distribution in commerce of the substance and products or articles containing it, with some exclusions.
Phenol, Isopropylated Phosphate 3:1 (PIP 3:1) CAS 68937-41-7	Processing and distribution in commerce of the substance and products that contain it, with specific exclusions. The release of PIP 3:1 to water during manufacturing, processing, or distribution. Notification and recordkeeping requirements for person who manufacture the chemical, process it, or distribute it in commerce.
2,4,6-tris(tert-butyl)phenol (2,4,6-TTBP) CAS 732-26-3	The distribution in commerce of the substance and products containing it at concentrations above 0.3% in any container with a volume less than 35 gallons for any use. The processing and distribution in commerce of the substance and products containing it in concentrations above 0.3% by weight for use as an oil lubricant or additive, regardless of container size.

Hereby Marcegaglia Carbon Steel S.p.A. declares that products or articles provided do not contain any of chemicals listed in the Section 6(h). Also, Marcegaglia Carbon Steel S.p.A. declares that manufacturing processes do not use any chemicals that are prohibited by the new Section 6(h) regulations.
