

**SUBJECT: REACH AND SVHC DECLARATION – CANDIDATE LIST UPDATE OF 01/17/2022 –
REGULATION (EC) No. 1907/2006 REACH**

Dear Customer,

we would like to inform you that, on the date 01/17/2022, ECHA issued an update of the SVHC substances included in Candidate List (ECHA/NR/22/01). The update concerned the inclusion of the following substances:

- 6,6'-di-tert-butyl-2,2'-methylenedi-p-cresol;
- tris(2-methoxyethoxy)vinylsilane;
- (±)-1,7,7-trimethyl-3-[(4-methylphenyl)methylene]bicyclo[2.2.1]heptan-2-one covering any of the individual isomers and/or combinations thereof (4-MBC);
- S-(tricyclo(5.2.1.0^{2,6})deca-3-en-8(or 9)-yl O-(isopropyl or isobutyl or 2-ethylhexyl) O-(isopropyl or isobutyl or 2-ethylhexyl) phosphorodithioate.

The Candidate List of Substances of Very High Concern now contains 223 chemicals that may harm people or the environment.

According to REACH Regulation manufacturers and importers of substances on the European market are obliged to inform customers about the presence of SVHC substances, if present above the limit of 0.1% weight/weight in mixtures or articles.

From the date of 5 January 2021 onwards, suppliers should also notify ECHA under the Waste Framework Directive if their products contain substances of very high concern. This notification is submitted to ECHA's SCIP database.

With reference to core business, we underline that Marcegaglia Specialties S.p.A. products are all included in the definition of article stated in the Regulation (CE) No. 1907/2006 of the European Parliament and of the Council dated December 18th, 2006. As per art. 7 "*Registration and notification of substances contained in articles*", paragraph 1 letter b), such articles are not subject to registration since the substances they may contains are not foreseen to be released under normal or reasonably predictable condition of use.

We also declare that except for the products listed below, pursuant to Regulation (EC) No. 1907/2006, the articles supplied by Marcegaglia Specialties S.p.A. do not fall within the obligations under art. 33 "*Obligation to communicate information on substances in articles*" as the percentage by weight of the substances included in the Candidate List, if present, is less than 0.1% of the total weight of the article.

At the same time, we hereby inform you that the following articles contain metallic Lead (CAS number: 7439-92-1) higher than 0.1% weight/weight. This substance has been included in the Candidate List with the update of 27 June 2018:
